



- 4. The Committee deliberated on the proposal based on the details provided and the presentation made by the Project Proponent (PP). During the discussion, the PP responded to the ADS raised by the EAC and stated that the proposed desalination plant would involve an intake of 20 MLD of seawater, from which 6 MLD of permeate water would be used for industrial processes and 14 MLD would be discharged as reject water. This information is also reflected in S. No.5 (page 2) of the CRZ recommendation letter issued by PCZMA dated 15/10/2024. The PP further clarified that, to avoid any potential conflicts with the port expansion plans of M/s Karaikal Port Private Limited (KPPL), a consultative meeting was held with the Port Department, Government of Puducherry, on 15/05/2025. During this meeting, the Master Plan of KPPL and the proposed desalination plant of M/s. Chemplast Sanmar Limited (CSL) were discussed in detail. It was noted and mutually agreed that "no land belonging to M/s. Chemplast Sanmar Ltd. will be affected, and the Master Plan of KPPL will be revised to accommodate CSL's proposed facilities, thereby ensuring the co-existence of both entities without any land use conflict". The PP also submitted a letter from the Port Department dated 02/06/2025, confirming this understanding. However, during the presentation, the Committee noted a slight variation in the project layout presented at the meeting when compared to the layout and KML file uploaded on the PARIVESH portal. In response, the PP explained that the initial layout included a portion of land erroneously shown as part of M/s. KPPL's property, which was identified and corrected during the meeting held on 15/05/2025 with the Port Department. The Committee accepted the Project Proponent's (PP) explanation and directed them to submit all documents and explanations via email immediately. The PP submitted the following documents via email on 26/06/2025:
- · Revised KML file of the proposed project layout.
- · Copy of the minutes of the meeting held on 15/05/2025 with the Port Department.
- · Lease deed with the Port Department for the use of Port land.
- · Land ownership documents for CSL-owned land.
- · An undertaking stating that there is no overlap between the proposed desalination plant and KPPL's land.

The Committee reviewed the documents / information submitted by the PP during the finalization of the

minutes and found it to be satisfactory. The Committee also suggested that aforesaid documents be uploaded on PARIVESH Portal for Ministry record by raising an Additional Detail Submission (ADS), once the minutes are approved, prior to processing the proposal for clearance by Ministry and same has been accepted by PP. Accordingly, ADS was raised on 11/07/2025 and in response PP has uploaded the necessary documents on 11/07/2025.

- 5. The Committee, after detailed deliberations and considering the submissions made by the project proponent, has recommended the proposal for CRZ Clearance as per CRZ Notification, 2011, subject to terms and conditions as stipulated during its 406<sup>th</sup> meeting held on 26/06/2025.
- 6. Based on the recommendation of the Puducherry Coastal Zone Management Authority and considering the submissions made by the project proponent, the Ministry of Environment, Forest and Climate Change, in acceptance of the recommendations of the Expert Appraisal Committee (CRZ), hereby accords CRZ Clearance to the project for "Construction of 6 MLD desalination plant along with associated sea water intake and outfall system at RS no. 206, Village Melavanjore, T.R. Pattinam, Karaikal, Puducherry UT by M/s Chemplast Sanmar Limited" under the provisions of the CRZ Notification, 2011 and amendments thereto, subject to the compliance of terms and conditions as under:-

### Specific Conditions

1	All construction shall be strictly in accordance with the provisions of the CRZ Notification, 2011, as amended from time to time.
2	The project proponent should lay the intake pipeline, outfall pipeline and product pipeline as proposed and without change in the proposed intake point and outfall point.
3	PP should ensure that no other untreated /treated water discharged through the proposed pipeline.
4	As committed and clarified, no overlap between the proposed desalination plant and KPPL's land/port expansion activity.
5	PP should obtain Consent to Establish (CTE) / No Objection Certificate from SPCB before the start of the construction activity of the project, as applicable.
6	The Project Proponent shall enhance tree plantation efforts under the campaign "एक पेड़ माँ के नाम" (Ek Ped Maa Ke Naam)." The details of the trees planted must be uploaded on the official portal <a href="https://merilife.nic.in">https://merilife.nic.in</a> .
7	Construction material/ debris generated during the project activity should be strictly implement in accordance with the Construction & Demolition Waste Management Rules, 2016.
8	All the mitigation measures listed in the EIA report should be implemented without any deviations.

9	Topsoil excavated during construction activities shall be stored for use in horticulture/landscape development etc. within the project site.
10	No groundwater shall be extracted within the CRZ area to meet the water requirements during the construction and/or operation phase of the project.

14	Construction material and structures/scaffoldings erected for construction at site shall be cleared immediately after finishing construction and it shall be ensured that no construction waste, garbage and machinery or equipment are left post construction.
15	The Project Proponent shall comply order/direction, if any, issued by Hon'ble Court / tribunal on the project.
16	All the conditions stipulated by the Puducherry Coastal Zone Management Authority for CRZ clearance under CRZ Notification, 2011 <i>vide</i> letter No. 2316/DST&E/PCZMA/CRZ/CLR/SCI/2024/369, dated 15/10/2024 and commitments made by the PP before the Puducherry CZMA and EAC shall be followed in letter and spirit.
17	All necessary clearance from the concerned authority, as may be applicable should be obtained prior to commencement of project or activity.

3	Disposal of muck during construction phase should not create any adverse effect on the neighbouring communities and be disposed taking the necessary precautions for general safety and health aspects of people, only in approved sites with the approval of Competent Authority.

4	All liquid waste arising from the proposed development will be disposed of as per the norms prescribed by Central / State Pollution Control Board. There shall not be any disposal of untreated effluent into the sea / coastal water bodies. It shall be ensured that the wastewater generated is treated in the STP as committed by the project proponent. The treated waste water shall be reused for landscaping, flushing and / or HVAC cooling purposes etc. within the development. The project proponent should also make alternate arrangement for situation arising due to malfunctioning of STP. There shall be regular monitoring of standard parameters of the effluent discharge from STP under intimation to the SPCB.
5	Any hazardous waste generated during construction phase, shall be disposed off as per applicable rules and norms with necessary approvals of the State Pollution Control Board.
6	A copy of the clearance letter shall be uploaded on the website of the concerned State Coastal Zone Management Authority/State Pollution Control Board. The Clearance letter shall also be displayed at the Regional Office, District Industries Centre and Collector's Office/ Tehsildar's office for 30 days.
7	A six-monthly monitoring report shall need to be submitted by the project proponent to the concerned Regional Office of this Ministry regarding the implementation of the stipulated conditions.
8	The Ministry of Environment, Forest & Climate Change or any other Competent Authority may stipulate any additional conditions or modify the existing ones, if necessary in the interest of environment and the same shall be complied with.
9	Full co-operation shall be extended to the officials from the Regional Office of MoEF&CC, during monitoring of implementation of environmental safeguards stipulated. It shall be ensured that documents/data sought pertinent is made available to the monitoring team. A complete set of all the documents submitted to MoEF&CC shall be forwarded to the concerned Regional Office of MoEF&CC.
10	In the case of any change(s) in the scope of the project, the project would require a fresh appraisal by this Ministry.
11	The Ministry reserves the right to add additional safeguard measures subsequently, if considered necessary, and to take action to ensure effective implementation of the suggested safeguard measures in a time bound and satisfactory manner, including revoking of the environment clearance under the provisions of the Environmental (Protection) Act, 1986, for non-compliance.
12	All other statutory clearances such as the approvals for storage of diesel from Chief Controller of Explosives, Fire Department, Civil Aviation Department, Forest Conservation Act, 1980 and Wildlife (Protection) Act, 1972 etc. shall be obtained, as applicable by project proponent from the respective Competent Authorities.
13	The project proponent should advertise in at least two local Newspapers widely circulated in

	the region, one of which shall be in the vernacular language informing that the project has been accorded CRZ Clearance and copies of clearance letters are available with the State Pollution Control Board (SPCB) and may also be seen on the website of the Ministry of Environment, Forest and Climate Change at https://parivesh.nic.in/. The advertisement should be made within Seven days from the date of receipt of the Clearance letter and a copy of the same should be forwarded to the concerned Regional Office of this Ministry.
14	A copy of the clearance letter shall be sent by the proponent to concerned Panchayat, Zilla Parisad/Municipal Corporation, Urban Local Body and the Local NGO, if any, from whom suggestions/ representations, if any, were received while processing the proposal.
15	The proponent shall upload the status of compliance of the stipulated conditions, including results of monitored data on their website and shall update the same periodically. It shall simultaneously be sent to the Regional Office of MoEF&CC, the respective Zonal Office of CPCB and the SPCB.
16	The environmental statement for each financial year ending 31st March in Form-V as is mandated to be submitted by the project proponent to the concerned State Pollution Control Board as prescribed under the Environment (Protection) Rules, 1986, as amended subsequently, shall also be put on the website of the project proponent along with the status of compliance of clearance conditions and shall also be sent to the respective Regional Office of the Ministry by e-mail.

- 7. This Clearance is subject to final order of the Hon'ble Supreme Court of India in the matter of Goa Foundation Vs Union of India in Writ Petition (Civil) No.460 of 2004 as may be applicable to this project.
- 8. The Ministry reserves the right to stipulate additional conditions, if found necessary at subsequent stages and the project proponent shall implement all the said conditions in a time bound manner. The Ministry may revoke or suspend the CRZ clearance, if implementation of any of the above conditions is not found satisfactory.
- 9. Concealing factual data or submission of false/fabricated data and failure to comply with any of the conditions mentioned above may result in withdrawal of this clearance and attract action under the provisions of the Environment (Protection) Act, 1986.
- 10. Any appeal against this CRZ clearance shall lie with the National Green Tribunal, if preferred, within a period of 30 days as prescribed under Section 16 of the National Green Tribunal Act, 2010.
- 11. The above conditions shall be enforced, *inter-alia* under the provisions of the Water (Prevention & Control of Pollution) Act, 1974, the Air (Prevention & Control of Pollution) Act, 1981, the Environment (Protection) Act, 1986, Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016 and the Public Liability Insurance Act, 1991 along with their amendments and Rules and any other orders passed by the Hon'ble Supreme Court of India/High Courts and any other Court of Law relating to the subject matter.
- 12. This is issued with the approval of the Competent Authority.
